Vendor agrees that he/she must obtain written approval of the Wimberley Lions Club Market Days Field Manager before commencing any construction, addition or improvements at the booth space.

Vendor agrees and understands the rule that no improvement on the booth space or building sitting thereon may be torn down or removed by the Vendor. Vendor does retain the right, while current on annual rental payments and in compliance with all applicable rules and regulations, to sell or transfer this rental agreement and any improvements on the booth space to another vendor with the approval of the Annual Rental Manager and with the proper application for such transfer.

Vendor understands and agrees that he/she must renew this rental agreement by October 15, 2009 or, after that date one cannot transfer ownership of improvements on the booth space although he/she will retain the right to use the booth space for the November and December 2009 Market Days.

Vendor further agrees that he/she will indemnify and hold Wimberley Lions Club and its members free and harmless from any, and all, claims, demands or causes of action arising out of, or resulting from, the use of the booth space herein rented and sales incident thereto.

Vendor understands that upon his/her failure or refusal to comply with this rental agreement or the 2009 Market Days Information and Rules, Wimberley Lions Club, at its sole discretion, may cancel this rental agreement without refund of the rental fee.
